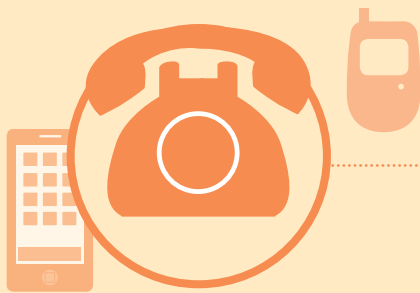

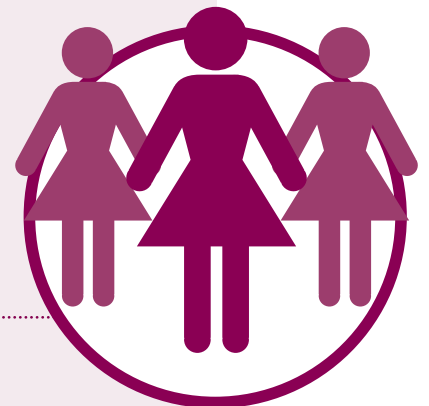

Breast Cancer 360s

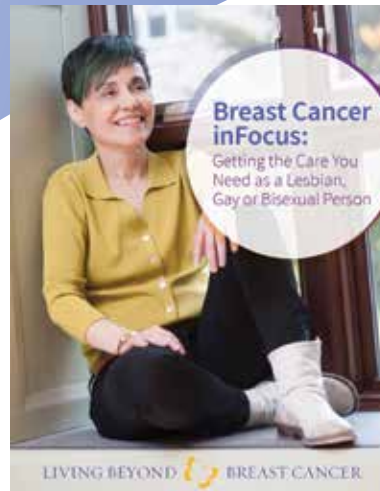
